

Food Scrap Collection



PROGRAM AVAILABLE

Monterey City Disposal Service Inc. (MCDS), and the City of Monterey would like to introduce to you the Food Scrap Collection Program. The purpose of this program is to make it simple and convenient to participate in composting by adding food scrap collection to your existing waste service. Much like with mixed recyclables, the food scrap collection program will allow you to add an additional container(s) for separating food scraps from other types of waste.

Our goal, is to develop the program into a valuable service that reduces landfill disposal, increases city-wide recycling rates, and produces a valuable compostable material which may also be utilized as an energy source and to assist commercial customer in meeting the requirement of California Assembly Bill 1826 (<http://www.calrecycle.ca.gov/Recycle/Commercial/Organics/FAQ.htm>).

California Assembly Bill 1826 requires businesses to recycle their organic waste based on the amount and type of waste the business produces on a weekly basis. It went into effect in April 2016 and full implementation will be realized in 2019.

AB 1826 phases in the requirements for businesses over time based on the amount and type of waste the business produces on a weekly basis, with full implementation realized in 2019. The implementation schedule is as follows:

Date	Requirement
1/1/2017	Businesses that generate 4 cubic yards of organic waste per week shall arrange for organic waste recycling services.
1/1/2019	Businesses that generate 4 cubic yards or more of commercial solid waste per week shall arrange for organic waste recycling services.
9/15/2020	Businesses that generate 2 cubic yards or more of commercial solid waste per week shall arrange for organic waste recycling services.
